# 39 G. PUBLIC HEARING

Variance (VA 2009-02), Conditional Use Permit (U 2009-11) & Design Review (DR 2009-11): Consideration of two Variances: 1) to allow a 3'-0" front yard setback, where 20'-0" is required and 2) to allow parking within the 20'-0" front yard setback along Hazel Street. This project also includes the consideration of a Conditional Use Permit and Design Review application to expand and operate a bistro (i.e. a restaurant) primarily focused on wine tasting and retail sales within an existing 600 square foot structure on the property located at 1224 Lincoln Avenue (APN 011-253-002) within the "DC-DD", Downtown Commercial - Design District. The applicant is Frank and Eugenia Romeo of Romeo Vineyards & Cellars, LLC. This proposed action is exempt from the California Environmental Quality Act (CEQA) under Section 15332 of the CEQA Guidelines

**Chairman Manfredi** referenced a memo provided by Planner Lundquist (Communications Item E) advising there was a lack of quorum to discuss this item; therefore he recommended the item be continued to the next regular Planning Commission meeting of February 10, 2010. See Minute attachment.

There was motion by **Chairman Manfredi**, seconded by **Commissioner Coates** to continue the item to the February 10, 2010 Planning Commission meeting. **Motion carried: 3-0-2-0**.

# J. MATTERS INITIATED BY COMMISSIONERS

**Chairman Manfredi** opened discussion suggesting due to the current economy, City budgetary constraints, and to show solidarity and support for the voluntary furlough efforts of City personnel he recommended a voluntary 10% reduction of the Planning Commissions stipends. There was motion by Chairman Manfredi, seconded by Commission Kite to authorize a 10% reduction to the Planning Commission Stipend. **Motion carried: 3-0-2-0**.

# K. DIRECTOR'S COMMENTS/PROJECT STATUS

Urban Design Status – **Planner MacNab** reported the City Council approval of the Urban Design Plan during their meeting of January 19, 2010. Director Gallina is currently working on the Urban Design implementation plan for presentation during the later part of February.

**Commissioner Kite** noted he felt it was very important for implementation to proceed as quickly as possible, at least showing the public minor tangible improvements in the community.

**Commissioner Manfredi** concurred, especially considering the long preparation of this document.
