 - One (1) member shall be, by training or life experience, able to represent senior issues;
 - One (1) member shall be, by ethnic background, training or life experience, able to represent Hispanic community issues;
 - One (1) member shall be a licensed design professional such as a Landscape Architect, Architect, or Civil Engineer;
 - The balance of the membership shall be "at large".
