**COVENANT AND AGREEMENT TO ACCEPT DRAINAGE  
WATERS, AND TO RELEASE AND INDEMNIFY**

THIS COVENANT AND AGREEMENT (the "Agreement") is made and entered into this  
\_\_\_\_ day of \_\_\_\_\_, 2010, by Vincent Arroyo and Marjorie Arroyo, as Trustees of the  
Arroyo Family Trust, dated November 7, 2003 ("Arroyo") and the City of Calistoga ("City").

RECITALS

A. Arroyo is the owner of certain real property (the "Property") located in the City of  
Calistoga, County of Napa, State of California, generally located south of Grant Street and west  
of Garnett Creek, more particularly described as follows:

Parcels A through D of Parcel Map No. 2008-03, recorded in Book  
\_\_\_\_, pages \_\_\_\_ and \_\_\_\_ of Parcel Maps, Records of Napa  
County, State of California.

B. Arroyo intends to develop on the property four residential lots served by a private  
road.

C. In connection with the development of the Property, Arroyo has recorded Parcel Map  
No. 2008-03 (the "Parcel Map").

D. In connection with the development of the Property, Arroyo shall cause to be  
constructed a public drainage system along the south side of Grant Street ("Drainage System").  
Surface runoff water and storm water ("Drainage Waters") from Grant Street will be collected by  
the Drainage System and be discharged into earthen swales that will be constructed along the  
sides of the private road on the site. Drainage water shall be limited to the surface water and  
drainage from "Drainage System" per the approved plans for this property by Cullen-Sherry  
Associates, on file with the Calistoga Public Works Department. No additional waters shall be  
discharged onto Property.

AGREEMENT

In consideration of certain approvals by the City of Calistoga relating to the development  
of the Property, Arroyo hereby agrees as follows:

1. Acceptance of Drainage Waters. Arroyo agrees to accept on the Property the  
Drainage Waters being discharged from the Drainage System into the earthen swales along the  
private road.

2. Release and Indemnification. Arroyo agrees to release the City, its officers, employees and agents from any and all claims, demands, suits and other actions that Arroyo may now or in the future have against the City, its officers, employees or agents arising out of or incurred as a result of any harm caused by the Drainage Waters being discharged from the Drainage System onto and across the Property.

Arroyo agrees to defend, indemnify and hold harmless the City, its officers, employees and agents from any and all liabilities, expenses, claims or causes of action arising out of or alleged to be caused by or resulting from Drainage Waters discharged from the Drainage System onto or across the Property or from the approval of any street, drainage, grading or other improvement plans approved by the City relating to the disposition of the Drainage Waters.

3. Attorneys' Fees. The terms of this agreement shall be enforced by the City, its successors and assigns. In the event either party should bring an action to enforce the terms of this agreement, the prevailing party shall be entitled to reasonable attorneys' and expert witness' fees and other reasonable costs of suit.

4. Covenants Running With The Land. This Agreement and the covenants contained shall run with the land and shall be binding upon Arroyo, its successors and assigns, and shall continue in effect until such time as released by the City Council of the City of Calistoga, California.




