**BACKGROUND/DISCUSSION:** During the course of the 2009/2010 fiscal year, the Rudolph and Maria Felgenhauer Trust for the Calistoga Police Department has funded improvements to the Calistoga Police Department facility and has purchased equipment intended for use by the Department to enhance the level of service to the community.

The Trust not only made purchases of equipment and materials but also provided local scholarships, donated to youth activities and other worthwhile activities.

The Trust spent \$16,350 this fiscal year, which ended on August 31, 2010. A breakdown of those expenses is attached hereto in "Exhibit A". The Rudolph and Maria Felgenhauer Trust would like to donate materials listed in "Exhibit A" to the City of Calistoga. Equipment donated to the City shall remain in use by personnel of the Police Department until such time as it is declared surplus by the Chief of Police and sold at auction, the proceeds of which will be placed in the General Fund.

**FISCAL IMPACT:** The addition of \$16,350 in materials and equipment that have been purchased by the Trust for use by the Calistoga Police Department.

The Trust earned \$23,848.24 in investment income, minus management fees the total comes to \$19,616.61 up to eighty percent of which, or \$15,693.29 was available to spend for the year.
