**A RESOLUTION HONORING CLAYTON CREAGER FOR HIS SERVICE ON THE PLANNING
COMMISSION AND HIS COMMITMENT TO THE CITIZENS OF CALISTOGA**

1 **WHEREAS**, in January 01, 2001 through December 31, 2010 the City Council appointed
2 Clayton Creager to fill a seat for five consecutive terms on the City's Planning Commission.
3 Clayton Creager has acted responsibly in this role preserving, protecting and enhancing Calistoga's
4 unique small-town community character for residents and visitors alike; and

6 **WHEREAS**, given his natural leadership skill as a facilitator and the respect of his
7 colleagues, Clayton Creager quickly became the Planning Commission Vice-Chairperson in
8 January 2007 and dutifully held this position through the end of his term on the Commission; and

10 **WHEREAS**, Clayton Creager played a significant role in numerous projects of interest to the
11 community, the most important of which was the 2003 General Plan Update, which identifies the
12 hopes and desires of the community and serves as Calistoga's "constitution" for growth and
13 resource management into the year 2020; and

15 **WHEREAS**, Clayton Creager assisted the community in the review and approval of
16 countless other important projects including, but not limited to development of the Formula
17 Business Ordinance which serves to preserve the historic tradition of "one-of-a-kind" shops,
18 restaurants and visitor accommodations in Calistoga, the City's Sign Ordinance which provides for
19 signs that effectively present information to the public while also preserving and enhancing the
20 scenic beauty of Calistoga as an economic asset to the community, the development of the Growth
21 Management System Ordinance, service on the Grant Street Subcommittee which established
22 specific criteria for the ultimate engineering design of Grant Street, service on the Oversight
23 Committee for the development of the Urban Design Plan, and his active role on the Housing
24 Element Update Advisory Committee.

26 **WHEREAS**, because of his knowledge, experience and his dedication to Calistoga, Clayton
27 Creager is highly respected by his fellow Commissioners and the citizens of Calistoga; and

29 **WHEREAS**, the City of Calistoga Planning Commission expresses its sincere appreciation
30 to Clayton Creager for ten years of faithful service to the citizens of Calistoga through his
31 outstanding work as a City of Calistoga Planning Commissioner.

33 **NOW, THEREFORE, BE IT RESOLVED** the City of Calistoga Planning Commission hereby
34 honors Clayton Creager for dedicating his valuable time and tireless efforts to improve the quality of
35 life for the present and future citizens of the City of Calistoga.
