2 ISSUE: Consider the Community Resources Commission's (CRC's) recommendation
3 requesting that the regional waste agency reestablish the temporary dedicated
4 household hazardous waste collection events in upper Napa Valley.

6 RECOMMENDATION: Adopt Resolution

8 BACKGROUND / DISCUSSION: In the early 1990's, the City joined with up-valley
9 communities St. Helena, Yountville, and Napa County to form a waste management
10 agency to meet regional waste reduction and recycling requirements set forth by the
11 state. The agency is run by a board comprised of one representative from each of the
12 cities and two from the county. City Council Member, Karen Slusser serves as the City
13 of Calistoga representative. The agency, named Upper Valley Waste Management
14 Agency (UVA), hires the Upper Valley Disposal Service to collect recyclable items,
15 greenwaste, and trash from local homes and businesses. It also regulates activities and
16 user fees at Clover Flat Landfill.

18 In previous years, it has hired a hazardous waste hauling company to hold special
19 collection events at Calistoga Fairgrounds. Although in 2009 and again in 2010, the
20 regional waste agency cancelled household hazardous waste events held previously at
21 Calistoga Fairgrounds, due to reductions in funding.

22
23 As a result Calistogans have few options for safe and convenient disposal of most
24 hazardous wastes (see Attachment 2). City residents and businesses can deliver a
25 limited number of recyclable hazardous material types to Clover Flat Landfill, but must

26 travel much further out of their way to the collection facility near the City of American
27 Canyon to dispose of their most toxic, corrosive and hazardous wastes.

29 UJVWMA funded the HHW collection events held in previous years through fees charged
30 to users of Clover Flat Landfill. The events were free to all residents in up-valley
31 communities. The economic slump has led to less waste arriving at the landfill and
32 therefore less money collected in fees. To adjust for lower revenues, the agency has
33 decided to cut hazardous waste collections.

35 In May of 2010 the CRC made a similar recommendation and received favorable
36 support from the City Council but unfortunately the UJVWMA Board did not make the
37 necessary budget adjustments to fund the collection program. The CRC is still
38 concerned that the lack of convenient household hazardous waste collections will
39 encourage residents and businesses to stockpile dangerous materials or to dispose of
40 them inappropriately. As such, the CRC is again recommending that the City Council
41 adopt a resolution requesting the UJVWMA reestablish the temporary dedicated
42 household hazardous waste collection events in upper Napa Valley so that residents
43 can rely on at least once a year convenient collection. The CRC also recommends that
44 the City Council solicit support from the City of St. Helena, the Town of Yountville, and
45 the County so that the Agency realizes the importance.
